



Terms and conditions of sale - Nosy-Be Madagascar TSARA BEACH, BUNGALOWS, TABLE D'HÔTES & TAPAS BAR

The only lodge directly on Orangea Ampassy beach, facing the Sakatia islet.

25km from Fascène Nosy-Be airport, 18km from Hellville and 10km from Andilana.

Comprising 3 spacious bungalows, each with a terrace overlooking the sea and the islet, a mini bar, a small safe, a fan, a closet with shelves and a shower room with toilet. All beds are fitted with mosquito nets.

Internet access via wi-fi (best connection at the restaurant).

"Private" beach with 4 natural umbrella/sunbath/beach shower areas.

Parking: 2 parking spaces inside the compound and possibility of parking in front.

CONDITIONS OF SALE & PAYMENT

Accommodation and catering must be booked and paid for in advance by bank transfer. The establishment acknowledges receipt of the customer's booking by sending an e-mail to the address previously provided, summarizing the offer, the services booked, the prices, the general conditions of sale accepted by the customer and the booking dates. After confirmation, a deposit of 50% is required for stays of less than 7 days (balance to be paid 15 days before arrival), and for all bookings of more than 7 days, the entire stay is due on booking.

Taxes (local taxes, tourist taxes, etc.) are included in the price per night. Prices include VAT applicable on the date of the order, and any change in the VAT rate will be automatically reflected in the prices indicated on the date of invoicing. Any modification or introduction of new legal or regulatory taxes imposed by the competent authorities will be automatically reflected in the prices indicated on the date of invoicing.

Extras and activities are also payable on site in cash: in euros, dollars or local Ariary currency.

CANCELLATION POLICY

Cancellation conditions apply as soon as the reservation is confirmed.

In accordance with article L.121-21-8 12° of the French Consumer Code, customers are reminded that they do not have the right of withdrawal provided for in article L.121-21 of the

French Consumer Code. The conditions of sale of the reserved fare specify the terms of cancellation and/or modification of the reservation:

- Cancellation with full refund within 48 hours of booking.

- Cancellation with partial reimbursement of 50% of the amount paid up to 3 months before the start of the stay.

- Reservations with prepayment cannot be cancelled between 3 months and the start of the holiday.

- Date changes are possible up to 1 month before the start of the holiday. After this date, no changes will be possible.

All reservations are nominative and may not be transferred to a third party, whether free of charge or in return for payment.

CONDITIONS OF STAY

Arrivals are from 2 pm and the accommodation must be vacated by 11 am on the day of departure.

On arrival at Tsara Beach, customers must complete an arrival form and present proof of identity. The lodge reserves the right to cancel the reservation if the customer fails to show proof of identity. The customer agrees to use the room in a reasonable manner. Any behavior contrary to public morality or order will result in the guest being asked to leave the establishment without reimbursement.

In order to combat prostitution and sex tourism, "local overnight guests" are not allowed in our establishment. A bungalow booked as a single remains as a single.

All our accommodation is non-smoking. Guests are asked to smoke outside and to place their cigarette butts in the ashtrays provided.

Pets are not allowed on the premises.
